#### Echo Will No Longer be Mailed

Yes, you read the heading correctly. HAH Club will discontinue mailing the Echo to you starting with the September issue which is mailed in August. Why? Beginning in August, the Bremen Post Office will no longer be handling bulk mail, so everything will be done at the Lancaster Post Office. That may sound like an easy enough switch to make. But it is not. The Lancaster Post Office has shortened hours for dropping off bulk mail and the procedure is not user-friendly for anyone to drop the trays of newsletters at the back dock, go inside and pay and then have the person in charge of bulk mail check over the paperwork.

We will still have the Echo online (which is in color) and paper copies of each month's newsletter can be picked up at the HAH Office, the Clubhouse and both post offices. For a while, it will be trial-and-error to find out how many copies are necessary at each location.

According to the size of each month's newsletter, we will save between \$350 and \$450 a month in postage. We know everyone is not going to be happy with this change, but it was something that was going to take place eventually, it just came about sooner rather than later.

Or, if there is any chance you won't be able to attend, please make sure you request an Absentee Ballot so that your vote is counted! Absentee ballots can be requested from July 4<sup>th</sup> through July 24<sup>th</sup> from the office in writing; marked Absentee Ballots will need to be returned in the provided envelope by Friday, August 16 at 4:30 pm.

# NEWS FROM THE RANGE July 2019



It is natural for new shooters to have some anxiety about going to the range for the first time. We always tend to be nervous about trying new things, but this activity comes with lots of noise and a large dose of preconceived fears. Our Range Officers are prepared to help you feel comfortable and safe during your visit to the HAH Range. To help you feel at ease we ask you to remember the 4 following rules whether you're at home or the range.

- All guns are ALWAYS loaded—period. Always assume the gun is loaded, and check for yourself if someone hands one to you.
- ALWAYS keep the gun pointed in a safe direction. Never point the muzzle at anything you're not willing to destroy. **This is the primary rule of gun safety.**
- ALWAYS keep your finger off the trigger until ready to shoot. Your trigger finger is your safety device. Unless you're aiming at your target, your finger shouldn't be touching the trigger.
- ALWAYS be sure of your target, and what lies beyond it.

#### Operation Permits for Sewage Treatment Systems

The Hocking County
Health Department has a new permit that may affect you; a Sewage
Treatment System (STS) Operation Permit. Any STS permitted
after January 1, 2007, is required
to obtain this permit so systems
installed prior to this date, do not
currently have this permit.

The rules for STS in Ohio are covered by Chapter 3701-29 of the Ohio Administrative Code. This code was revised in 2007 and included the requirement for Operation Permits for any STS that was installed or altered after January 1, 2007. The rules left it up to the local health departments to determine the length of the permit not to exceed 10 years. The Hocking County Board of Health set the STS Operation Permits to expire at the maximum allowed length of 10 years.

The STS Operation Permit is issued once the STS is installed or altered. A reminder is sent to homeowners when the permit is ready to expire. To renew the permit, owners simply submit an application with the required fee. An inspection of the STS is also required and owners can choose to have the Health Department conduct the inspection for a small fee or they can hire a Registered Service Provider to conduct the inspection. There is a form for the Service Provider to fill out and return. The advantage of having a Service Provider conduct the inspection is they can usually make any necessary repairs at the same time. If the Health Department encounters any issues during the inspection, the owner would need to fix it then pay for another inspection.

Homeowners are allowed to conduct inspections for their personal residence; provided they register with the health department, pass the Ohio Department of Health Sewage Treatment System exam, and submits record of the inspection to the health department. Furthermore, if the STS does not consist of septic tank and leach, the owner must have specific manufacturer training for the system.

To streamline the renewal process, the Hocking County Health Department is looking into an online program that will allow owners and service providers to submit the application, fee and inspection report via the internet.

Although homeowners with systems installed prior to 2007 are not currently required to have an operation permit, the Ohio Department of Health would eventually like every STS in Ohio to have one.

Most states require STS Operation Permits because nothing lasts forever including sewage systems. This permit is in place to ensure STS are inspected at least once every ten years to confirm they are operating as designed and not causing a public health nuisance.

Properly installed and maintained STS are important for the health and welfare of the community and the environment. Human sewage contains a variety of organisms, chemicals, and pharmaceuticals which can cause human illness and damage bodies of water that support wildlife. Ponding sewage is a favorite for mosquitoes so it is important that systems are functioning properly. #### HIDE-A-WAY HILLS CLUB ORV RULES AS OF 3/25/17

#### **VEHICLES**

- 14. Notwithstanding the above numbered Vehicle Rules, and the Off Road Vehicle Rules that apply to the designated ORV track and trails, the following shall apply to all Off-Road-Vehicle (ORV) operators under the age of 16 when using Hide-A-Way Hills roadways. "ORV" shall include, but not necessarily be limited to any ATV, Utility Vehicle, Side-By-Side, Go-Kart, Dirt Bike or Golf Cart. It shall not include cars, vans, trucks and SUV's.
  - A. All ORV operators under the age of 16 and their parent(s) must attend a HAH ORV Rules Meeting sponsored by the ORV Committee.
  - B. No ORV may be operated by a person under the age of 12 without a parent or responsible adult present.
  - C. Such ORV operators must understand and comply with the vehicle manufacturer's recommendations for safe operation and ensure that the maximum number of passengers does not exceed the number of seats in the vehicle.
  - D. In addition, helmets must be worn by all such operators and riders of an ATV, Go-Kart or Dirt Bike. Seat Belts must be worn by all such operators and riders in vehicles where they are supplied. Go-Karts and other low-profile ORVs less than 4 feet from the ground must display a flag extending vertically at least 4 feet.
  - E. The parents of all under-age ORV operators must read and sign the "Parental Consent and Release" form acknowledging the inherent risk associated with operating an ORV, and attesting that they and their child understand and will comply with all HAH rules.
  - F. Upon confirmed attendance at an aforementioned ORV Committee sponsored meeting, and completion of the "Parental Consent and Release" form, a sticker will be issued for display on any ORV to be used by an underage operator. No ORV shall be operated by an underage driver on HAH roadways without such a sticker clearly displayed. Violations of these rules are subject to the Schedule of Fines section of the Hide-A-Way Hills Club Rules.

#### **OFF-ROAD VEHICLE (ORV) RULES**

The following rules cover use of the Hide-A-Way Hills ORV track and trail area. All existing Hide-A-Way Hills Club rules also apply.

- 1. The use of the ORV track and trail area is restricted to Hide-A-Way Hills members and guests on member owned ORVs. Social guests must be accompanied by the member.
- 2. Please enter the ORV track from the posted entrance point.
- 3. The ORV track is one-way only—counterclockwise. Do NOT go clockwise or cut the track.
- 4. When riding the trails through the woods, do not cross the signs marking the shooting range.
- 5. The ORV Committee strongly recommends that a certified helmet be worn by all riders.
- 6. The ORV Committee strongly recommends that participants riding in side-by-side UTV's fasten their seat belts.
- Due to the possibility of an accident requiring a call for medical assistance or other help, the ORV Committee strongly recommends that riders not be alone on the track or trails.
- 8. Riders are prohibited from using the ORV track or trail area while impaired by the use of alcohol or drugs.
- 9. Ride at your own risk, and take care to not exceed your ability to control your vehicle.

The ORV Committee strongly recommends that riders 12 and under be accompanied by a parent or adult.

The parent or adult should be at the track but does not have to ride.

The Hide-A-Way Hills Club Board of Trustees is asking for approval of the following proposed changes to the Code of Regulations:

#### **BALLOT ISSUE #2**

#### Proposed Amendments to the Definition of Member in the Code of Regulations, Article II, Section 1

#### **Background:**

At the 2010 Annual Membership meeting the membership voted to approve the Amended and Restated Code of Regulations. This vote followed a thorough review of the Code of Regulations by the Trustees for the purpose of updating and clarifying the language in the Code. One of the amendments made at that time omitted the words "and their spouses" from the definition of Members in Article II, Section 1.

This omission was, and is, inconsistent with both actual practice and the historic definition of "Member" in the Code of Regulations as well as in the Board-approved Club Rules. Therefore, in order to correct this inconsistency, the Board of Trustees is recommending that the following proposed amendments (in red) to Article II, Section 1 of the Code of Regulations be presented to the Membership for approval at the 2019 Annual Meeting.

#### SHOWING PROPOSED CHANGES:

#### Article II - Members; Dues and Assessments

<u>Section 1</u>...Members. Members of Hide-A-Way Hills Club shall be those persons who hold recorded title as owners of lots in the Hide-A-Way Hills development, and the spouses of such persons. The seller under a Land Contract is the "owner" or "member". Except for the purposes of spousal membership as per the above, Llot ownership and Club membership are automatically and irrevocably combined, and membership shall not be separated from ownership of a lot. Each owner, by acceptance of a deed to a lot, thereby becomes a Club member. If more than one person is the owner of a lot, each such person shall be a member. If an entity other than an individual person, such as a trust, estate, corporation or limited liability company is the owner of a lot, then such entity shall be a member, and shall designate in writing to the Club the names of two (2) owners of such entity who are authorized to use the Club facilities. In the event more than two (2) such beneficial owners are designated, then the Additional Assessment provisions of Article II, Section 4D.2 shall be applicable.

#### FINAL LANGUAGE:

#### Article II - Members; Dues and Assessments

<u>Section 1</u>...Members. Members of Hide-A-Way Hills Club shall be those persons who hold recorded title as owners of lots in the Hide-A-Way Hills development, and the spouses of such persons. The seller under a Land Contract is the "owner" or "member". #### **BALLOT ISSUE #3**

#### Proposed Amendments to the Definition of Member in the Code of Regulations, Article II, Section 4

#### **SHOWING PROPOSED CHANGES:**

<u>Section 4</u>...Dues & Assessments. The dues of members shall be the assessments imposed pursuant to this Code of Regulations, as amended from time to time, and paragraph 8 of the Deed Restrictions for Hide-A-Way Hills as to said lots and parcels.

Effective January 1, 2017 2019 the <u>Normal Lot Assessment</u> for a lot or parcel (whether developed or undeveloped) owned by a member or members, is \$160.97 \$168.53 per month.

Effective from January 1, 2020 through May, 2021 the Normal Lot Assessment shall be \$188.53 per month. Effective from June 1, 2021 through December, 2021 the Normal Lot Assessment shall be \$208.53 per month. Effective January 1, 2022 the Normal Lot Assessment shall be \$228.53 per month.

The currently established schedule for cost-of-living increases in the Normal Lot Assessment based on the Consumer Price Index (CPI-W) shall be suspended for the years 2020, 2021, and 2022, during which the above specified amendments take effect.

Effective January 1 of each calendar year from 2018 2023 through 2027, said Normal Lot Assessment shall increase each year by the percentage of increase in the Consumer Price Index for all Urban consumers (CPI-W\*), as established by the Bureau of Labor Statistics of the U.S. Department of Labor, for the preceding month of September of each calendar year as compared to the identical index issued for the month of September of the previous calendar year, with a limit to the increase of 5% of the normal lot assessment charged for the prior calendar year. In the event of a decrease in the index, there shall be no decrease in the Normal Lot Assessment.

These assessments shall be payable in advance, either annually, semi-annually, quarterly or monthly.

\*CPI-W is the Bureau of Labor index that is tied to Social Security.

#### **FINAL LANGUAGE:**

<u>Section 4</u>...Dues & Assessments. The dues of members shall be the assessments imposed pursuant to this Code of Regulations, as amended from time to time, and paragraph 8 of the Deed Restrictions for Hide-A-Way Hills as to said lots and parcels.

Effective January 1, 2019 the <u>Normal Lot Assessment</u> for a lot or parcel (whether developed or undeveloped) owned by a member or members, is \$168.53 per month.

Effective from January 1, 2020 through May, 2021 the Normal Lot Assessment shall be \$188.53 per month. Effective from June 1, 2021 through December, 2021 the Normal Lot Assessment shall be \$208.53 per month. Effective January 1, 2022 the Normal Lot Assessment shall be \$228.53 per month.

The currently established schedule for cost-of-living increases in the Normal Lot Assessment based on the Consumer Price Index (CPI-W) shall be suspended for the years 2020, 2021, and 2022, during which the above specified amendments take effect.

Effective January 1 of each calendar year from 2023 through 2027, said Normal Lot Assessment shall increase each year by the percentage of increase in the Consumer Price Index for all Urban consumers (CPI-W\*), as established by the Bureau of Labor Statistics of the U.S. Department of Labor, for the preceding month of September of each calendar year as compared to the identical index issued for the month of September of the previous calendar year, with a limit to the increase of 5% of the normal lot assessment charged for the prior calendar year. In the event of a decrease in the index, there shall be no decrease in the Normal Lot Assessment.

These assessments shall be payable in advance, either annually, semi-annually, quarterly or monthly.

Clubhouse sales were down \$847 and expenses were up over \$3,100 compared to last year.

Clubhouse profit was over \$1,765 which is down \$4K from last year.
