It has been a 3+ year journey to raise funds, create drawings, create blueprints, receive engineering approval, get county permits, find contractors and the list goes on for the new deck at the Lodge.

We are happy to report that we broke ground the week of December 16.

The support columns for the deck and stairs will be completed with the construction of the deck soon to follow.

#### As a reminder:

• Approximately \$55,000 was raised as donations from members.

- \$20,000 was received from the Amenity Fund (The Amenity Fund receives 40% of the New Member Fee).
- Plans were approved by an engineer and county.
- Contractors are licensed.

This summer's concert season is going to have a new prime seating location! Thank you to everyone that donated time and money to this effort and for your patience!

The office remains open with the temporary entrance through the Great Room door.



# LOAD LIMITS IN 2/1/20 - 4/15/20



#### **GENERAL RULE #19**

"Load limits will be placed on all roads during inclement weather to prevent damage to the roads. No vehicles in excess of 13 ton, gross weight, will be permitted during such enforcement, except emergency vehicles. Penalty for violation of the load limits will be a \$500.00 fine to the member, per occurrence."

#### **Foreclosure Sales**

This was voted on at the December Board of Trustees Meeting

It has come to our attention that some financial institutions are by-passing the traditional Sheriff Sale and holding online auctions of properties in foreclosure actions. In order for the following rule to apply in all applicable sales, we are removing the references to "sheriff."

#### 26. FORECLOSURE AND DEEDS IN LIEU THEREOF

In the event of a foreclosure action against a property in Hide-A- Way Hills Club, the property owner, and any guests thereof, shall be deemed to be not in good standing and shall forfeit all privileges of membership (or guest privileges, if applicable) at Hide-A- Way Hills Club.

If an Entry Confirming Sale has been filed with the Clerk of Courts having jurisdiction over the foreclosure action, the General Manager may notify the occupant that they shall have seven (7) calendar days from the date of said notice to remove all personal property and vacate the premises, irrespective of any longer time provided by the Entry Confirming Sale. Said notification shall be by Certified Mail and by personal delivery, or by posting the notice on the property by Hide-A-Way Hills Security. Also within seven (7) calendar days from the date of said notice, the owner shall return all key cards and gate openers to the Club. Membership and guest privileges are terminated on the date of the **sheriff**-sale or on the date of execution by the property owner of a deed in lieu of foreclosure.

The purchaser at sheriff-sale is responsible for all assessments, costs, charges, and for compliance with the Deed Restrictions, Code of Regulations, and Rules of Hide-A-Way Hills Club as of the date of the sheriff-sale regardless of when the sale is confirmed or when the deed is recorded. If the sale is vacated or not confirmed, membership shall revert to the property owner who shall be responsible for any and all assessments, legal fees and costs owed until such time as a new sheriff-sale occurs, a deed in lieu of foreclosure is executed, or the property is otherwise transferred in accordance with these Rules and the Code of Regulations. Nothing herein relieves the member of liability for any sums due to Hide-A-Way Hills Club.

The grantee of a deed in lieu is jointly and severally (with the grantor thereof) responsible for all assessments, costs, charges, and for compliance with the Deed Restrictions, Code of Regulations, and Rules of Hide-A-Way Hills Club attributable to the property described in said deed in lieu, to the extent such assessments, costs and charges arose prior to the execution of said deed in lieu. In addition, such grantee shall be responsible for each of the foregoing subsequent to the execution of said deed in lieu.

#### Proposed Changes to the Hide-A-Ways Hills Club Building Code November 14, 2019

This was approved at the November 19, 2019 meeting of the Board of Trustees Changes are in bolded red and underlined

**200.08 OCCUPANCY PERMIT** – An ACC member and the General Manager will review the construction site to verify all Hide -A-Way Hills Building Codes have been met. A Certificate of Occupancy will be issued when construction is complete, <u>all construction material and waste has been removed</u>, all utilities are in working order, and all plumbing has been inspected and approved by the County Health District. <u>A Certificate of Occupancy will not be issued and the applicable construction deposit</u> will be forfeited if the aforementioned requirements have not been met.

### **Amenity Fund Distribution**

The Amenity Fund monies come from 40% of the New Member Fee. Committee Chairs got together in December and ranked their "Wish List" of projects. There is a tremendous amount of cooperation especially this year since there were requests for \$236,474.23 with \$142,672.17 in the fund. The Amenity Fund came about many years ago as a way for our committees to make improvements to our amenities.

These funds should not be confused with the Committee Funds which are monies that the committees raise through fundraisers and need Board approval before spending.

A first offense will result in a warning; second offense and thereafter will result in a \$100.00 fine. Additionally, any fine assessed to the Club by the Department of Health that can be attributed to any individual Club Member(s) will be passed on to the individual(s) as a separate assessed fine.

#### 6. SAFETY RULES

- a. Absolutely NO SMOKING OR USE OF AN E-CIGARETTE OR OTHER VAPING DEVICE IN OR AROUND THE BARN State Fire Law.
- b. Do not mount or dismount within the barn.
- c. Close all gates and doors when leaving the barn.
- d. No horse shall be stabled that presents a hazard to other members or their horses.
- e. Riding after dark on HAH roadways is prohibited.
- f. Hide-A-Way Hills Club is not responsible for accidents or injury to individuals caused by horses. All horse owners must carry a minimum of \$250,000.00 liability insurance that covers accidents or injury to others. Proof of current insurance must be presented to the General Manager each January 1.

#### **GOLF CLUBHOUSE/SHELTER HOUSE**

- Authorized, scheduled, Club functions and Golf Committee functions, in that order, shall
  have first priority on shelter house use. All activities and functions at the shelter house
  must be terminated by 11:00 p.m. and the premises vacated by 12:00 midnight.
  Smoking/vaping is permitted within the confines of the Golf Shelter House.
- 2. No person under the age of 21 will be served alcoholic beverages.
- 3. No alcoholic beverages which would violate the Club's Liquor License may be brought or removed from the Golf Course premises.
- 4. No alcoholic beverages will be sold on Sundays, except those produced at the HAH microbrewery, unless an extension of the liquor license(s) is secured.
- 5. The bartender has the authority to refuse service and/or remove anyone for disorderly conduct, malicious mischief or intoxication.
- 6. No pets are allowed in the Clubhouse.
- 7. Proper attire must be worn at all times.
- 8. Children must be supervised at all times and remain under the control and responsibility of the accompanying adult, guardian or guest.

#### MANAGEMENT COMMITTEE REPORT - Jim Kirk

Members contributed over \$20,500 to the HAH Employee Christmas Fund! The employees want me to express a big thank you to all the members that contributed.

Packages being received at the Guard Shack are exceeding 125 per day Monday thru Friday PLUS an additional 80+ on Saturday. This includes FedEx, UPS, DHL, Amazon and US Postal Service. Security is now allocating 48 hours of security guard time per week exclusively to handle the process of receiving the packages, calling the members, and handing out packages.

We have an issue with members NOT picking up packages in a timely manner. Packages must be picked up within 3 days or they will be shipped back.

#### Lodge/Clubhouse Update:

- Lodge November sales were \$26,102 which is an increase of almost \$8,400 over October and within \$700 of matching last November. November's loss of \$9,529 was down over \$7,500 from October.
- Clubhouse November sales were \$18,199 and November's expenses were \$21,218 resulting in a loss of \$3,020. Staffing levels have been adjusted to reflect the seasonal downturn in evening business.
- Staffing at both locations is getting closer to normal. Clubhouse staff has been helping when needed at the Lodge especially in the bar due to a recent loss of staff.
- Food Service Committee has met 5 times and welcomed two new members, Eric Lapp and Jeff Barron. A big New Year's Eve Party is planned which is a combined effort of both the Lodge and the Clubhouse.


