NEWS FROM THE RANGE



Everyone needs to focus on having a “SAFE Summer”! The S.A.F.E. in “SAFE Summer” serves as an acronym for (S)-ecure your firearms when not in use; Be (A)ware of those around you who should not have unauthorized access to guns; (F)ocus on your responsibility as a firearm owner; and (E)ducate yourself and others about safe firearm handling and storage. All gun owners need to take responsible actions to help keep their families and communities safer.

Just because your children and grandchildren don’t ask about guns, doesn’t mean they don’t have questions! Take time to educate kids about guns. Teach them to fear what a gun can do in the hands of an irresponsible person, NOT to fear all guns. They need to understand the reality of guns and how to properly handle them.

Nearly all firearm accidents in the home can be prevented when gun owners take simple precautions, and proper storage is the number one way to help prevent accidents. Secure it when not in use to help prevent firearm accidents and misuse.

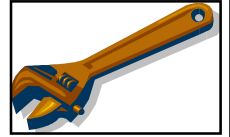

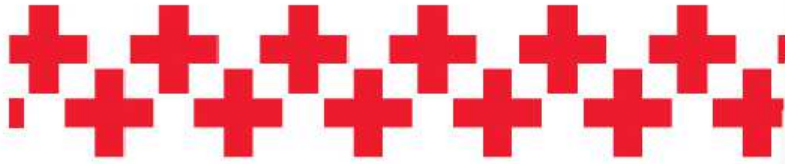

2017 Annual Membership Meeting

Explanation of Proposed Changes to the Code of Regulations

The Board of Trustees approved the following proposed Code of Regulations amendments to be presented to the Club Membership for their consideration and approval:

BALLOT ISSUE #2

The current Code language provides for annual increases in the Normal Lot Assessment based on increases in the U.S. Department of Labor's Consumer Price Index through 2018. The proposed change extends the effective date for such increases from January 1, 2018 to January 1, 2027. Since tying assessment increases to the CPI, the Club has been financially stable and has been able to avoid big dues increases. Dues went from \$137.22 in 2008 to \$160.97 in 2017. That is an average annual in the monthly assessment of only \$2.64 per month each year. The specific proposed changes to the current Code language are provided below (deletions and **additions**):

Article II, Section 4, A. Dues and Assessments. The dues of members shall be the assessments imposed pursuant to this Code of Regulations, as amended from time to time, and paragraph 8 of the Deed Restrictions for Hide-A-Way Hills as to said lots and parcels.

- A. Effective January 1, 2008 **2017**, the Normal Lot Assessment for a lot or parcel (whether developed or undeveloped) owned by a member or members, was increased by \$9.22 per month to the amount of \$137.22 **is \$160.97** per month.

Effective January 1 of each calendar year from 2009 **2018** through 2018 **2027**, said Normal Lot Assessment shall increase each year by the percentage of increase in the Consumer Price Index for all Urban consumers (CPI-W*), as established by the Bureau of Labor Statistics of the U.S. Department of Labor, for the preceding month of September of each calendar year as compared to the identical index issued for the month of September of the previous calendar year, with a limit to the increase of 5% of the normal lot assessment charged for the prior calendar year. In the event of a decrease in the index, there shall be no decrease in the Normal Lot Assessment.

These assessments shall be payable in advance, either annually, semi-annually, quarterly or monthly.

*CPI-W is the Bureau of Labor index that is tied to Social Security.

BALLOT ISSUE #3

The current Code language provides that the Board President shall appoint members of the Nominating Committee in March of each year. The proposed change simply moves this date to January of each year in order to provide sufficient time for the Nominating Committee to complete its work. The specific proposed change to the current Code language is provided below (deletion and **addition**):

Article VII, Section 3, paragraph 2 Nominating Committee

Composition and Timing. At the March **January** regular meeting of the Board, the President shall appoint from the members (two of whom shall not be the members of the Board) a committee of five persons, with the President as Chairman, to nominate members for the Board of Trustees for the ensuing election.

BALLOT ISSUE #4

This proposed change clarifies that a before a Special Individual Assessment is enforced against a member, they may cross-examine any witness against that member at the hearing. The specific proposed change to the current Code language is provided below (**addition**):

Article IX, Section 2, b. Special Individual Assessments.

- b. Prior to any Special Individual Assessment being enforced by the Club against any member, that member shall have the right to a hearing before the Board or duly appointed committee and a right to cross-examine any witness against that member **at the hearing**. Such rights must be exercised, in writing, within 10 calendar days of the Special Individual Assessment notification, or the right is forfeited. Hearings shall be held in closed session unless an open session is requested by the member(s).

HARCUM PARK ORV RULES

Approved by the Board of Trustees on April 18, 2017

SHEETS ROAD PROPERTY

The common natural area known as the Sheets Road Property is available for hiking, horseback riding and quiet recreational use. The following rules apply when utilizing this area:

1. Motorized vehicles are permitted only on Maya Lane and the designated parking area, except authorized security, emergency and maintenance vehicles. Vehicle parking is available off Maya Lane except as stated in item 5.
2. Trespassing onto adjacent private property is prohibited.
3. No fires of any kind are permitted.
4. Access is permitted only during daylight hours.
5. Side-by-side utility vehicles will be allowed ingress and egress only to Harcum Park from May 1 through October 31. They must stay on trail to Harcum Park.

Quads or ATVs and dirt bikes are prohibited.

Use four-wheel-drive.

Speed limit is 5 mph. Use caution, pedestrians or horses may be on the trail.

Three keys to a gate by the Maya Lane parking area will be available at security on a first-come first-serve basis.

Keys must be signed out and signed in when returned.

Users must close and lock the gate upon entrance and exit.

6. Harcum Park hours restricted to 11 AM to 8 PM or sunset whichever comes first. Keys cannot be picked up before 10:30 AM or after 6 PM.
7. The trail to Harcum Park may be closed at the discretion of security if heavy rain or conditions makes the trail unsafe.
8. The entire area is a quiet zone. Once you get to the top park your vehicle. Enjoy the beauty and serenity of Harcum Park but please respect the privacy of the members who own the house in The Reserve.
9. All Hide-A-Way Hills rules pertaining to common ground apply to the reserve of Hide-A-Way Hills also.
10. Infractions of the Harcum Park guidelines or Hide-A-Way Hills rules could result in fines being assessed or depending on the seriousness of the infraction an Article IX with a minimum fine of \$250.

HAH Rule Changes to the Fine Schedule

Approved by the Board of Trustees on 4/18/2017

Class 2 Definition: An offense that has caused or could have caused minor injury to the accused or to another person or has caused minor loss of or damage up to \$500 to any personal property or Club property.

Class 4 Definition: More serious offenses or violations, that could have or has caused serious injury or damage and/or willful destruction of personal or Club property, will be referred to the Board of Trustees for Article IX action and will result in a minimum fine of \$250.00 plus restitution of losses.

This Fine Schedule is not intended to supersede any previous fine references contained in the Hide-A-Way Hills Club Rules.

He reported that a reception was held for all committee chairs to thank them for their leadership.

There have been several incidents in the past two months when dogs were loose and chasing walkers in the community. A dog on its own lot was bitten by the neighbor's dog and a member was bitten while walking his dog. Ptacin asked that members keep their dogs under control.

TREASURER'S REPORT – Ginger Reed

Total Committee funds in the Vinton County National Bank on May 31, 2017 were \$69,261.47. Motion to approve made by Ginger Reed; second by Tom Mathews – **Motion Carried**

Greg Ptacin presented an adjusted Year to Date (YTD) P&L that excluded Dam Assessment revenue and most Dam expenses. He explained that the financials including Dam Assessment revenue show the bottom line \$151,513 over last year. When he took out the Dam assessment revenue and the obvious Dam related expenses we are approximately \$33,000 below last year. However, the YTD is still a positive \$60,000. He said his numbers are only estimates and there may be Dam expenses included in other accounts. Ptacin will have the YTD through June done by someone with a full understanding of our bookkeeping so that the Board and members have an accurate picture of how HAH is doing.

MANAGEMENT COMMITTEE REPORT – Jim Krygier

- LOFS: Three ODNR engineers inspected all five of our dams on May 31, 2017. They were very thorough and the result is that all dams passed! There will be follow-up comments (there always are) that we will receive later this year. The next dam inspection will be scheduled for summer of 2022.
- The MC continues to evaluate and discuss parking and access issues on the dam. The safety bollards will soon be installed across the spillway and lights sometime in July. We will also evaluate trailer and boat parking. We ask for patience as we work through these issues.
- North Park: The area is now open for use from dawn to dusk. Please use caution and do not park on the newly sown grass. The area is still covered by an EPA permit until the ground cover is well established.
- Lodge and Food Services: We are actively searching for a new Food Services GM as Gerard Shay has accepted a new position. Kat Sigler has been promoted to the Assistant Manager for Dining Room Services. We will be in transition mode for the immediate future as we work to return to full staffing. Thanks for your support and patience.

GENERAL MANAGER'S REPORT – Randy Swetnam

- Delinquency totals for May, 2017 were \$57,562 for regular assessments and as of this month \$55,072; Roads assessments are up a little bit due to the older account late fees. The current delinquent lists shows no one on the 60 days list for regular assessment and no one going to attorney for the regular assessments. There are about six members on the 60 day list for the Dam assessment; however they seem to pay once they receive letter and/or phone call. Dam assessment total as of yesterday was \$312,669. We still owe Igel about \$145,000 for retainage and we were a little bit concerned we would not be able to maintain a balance to make our monthly payments, but we have been able to keep a high enough balance to make those payments.
- You probably noticed the road closures from time to time here within the last week on Hide-A-Way Hills Roads because maintenance is installing six culverts before the Motopave project starts this year. That will continue this week and next until all installations are complete.
- We have had issues with the air conditioning unit at the Clubhouse for some time, so are getting a new unit installed tomorrow.
- We will have a new furnace and heat pump replacement for the dining room that will give us all new equipment. There will be two units; one in the kitchen and one in the dining room. The one in the bar was replaced a couple years ago. They are coming in Monday to replace the unit in the dining room.
- We are going to be cleaning up the boat storage area starting next month.
- The motorcycle track has been rebuilt and is completed and it is going to be better for all riders regardless of their abilities. The track has been designed for the professional rider as well as the beginner.
- The port-a-johns are still at the front due to the failing septic system. We issued the contract to get the septic replaced this week and it will be another couple weeks before that actually gets underway.
- Discussions are ongoing regarding non-members somehow getting into HAH without a member's permission or a Realtor. Security does a terrific job, but people do get through and mostly due to our current exterior gate system.

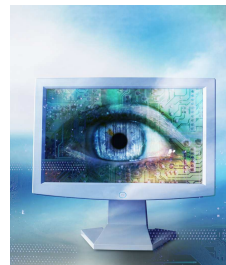
Per the paving company, the speed humps cannot be put back into the new pavement until this spring.
