President's Report

Have you thought about how much you get for \$171 each month in Hide-A-Way Hills? If not, consider that we have our own gorgeous 100-acre lake and docks (not to mention the other lakes), the golf course, two security guards on duty at all times, the swimming pool with a manager, life guards, and kiddie pool, the tennis/pickleball courts, the microbrewery, the shooting range, the two restaurants, the Chapel in the Pines, the amphitheater, the barn with stables, the ORV Track, playgrounds, and two shelter houses. On snowy winter days, your assessment dollars even go to work plowing and treating our roads which typically are in better condition than those of nearby townships. Our dedicated Maintenance staff members take our safety seriously and maintain the roads as well as anyone could with the available resources.

Maintaining this community costs money -- more than you might appreciate. Our talented staff members deserve competitive compensation, and if we don't recognize that, we will lose them to higher paying opportunities elsewhere. Our roads constantly need repair and improvement, but what they really need is a major investment that addresses structural issues where band-aid approaches are failing. Many of our roads are at risk and could quickly become one-lane roads or less if we don't attend to them seriously. Our equipment depreciates and must be repaired and sometimes replaced; I think you would be amazed at what some equipment costs to repair alone but if you're interested, give our HAH office a call, but make sure you are sitting down.

Do you know the members of our Management Committee (MC)? If you don't, you probably do know that they are your neighbors. Despite what a few negative voices say on social media, our neighbor-volunteers take their roles very seriously and do an excellent job managing HAH on your behalf. They

closely review all operations and expenditures. Through their steadfast efforts, the HAH budget was balanced even though it could only be accomplished by making some unpopular cuts including suspending support for Lodge operations. I personally believe they, and the Board, should be commended for doing what must be done.

The Board and MC have unanimously recommended an assessment increase for 2020. This is the third year in a row that we have asked for additional funds because it is THAT important to the well-being and livelihood of this community. Do not let the opportunity go by this time: Vote YES. In Hide-A-Way Hills every vote DOES count!

The vote is scheduled for August 16 at the Annual Meeting. The 2020 meeting will be abbreviated and socially distanced because of the Covid19 pandemic but you will be able to cast your votes there if you haven't already voted by Absentee Ballot. More details will be sent out separate from this letter.

All the best, and please, VOTE YES!

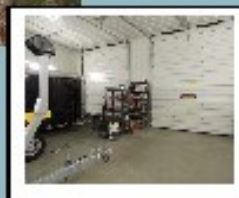

A Vote for My Neighbors

We are voting soon on an additional fee assessment of \$30 a month.

If the assessment passes, the total will be about \$200 a month or \$2,400 a year.

This is my 4th Summer as a resident of HAH. I'm paying pretty much the same assessment as the day I moved in.

I wouldn't be if I still lived in Delaware, Ohio. I was paying for services such as:

Water and Sewer (\$100)
Waste Management (\$65)

I was about breaking even with the HAH's monthly assessment before I factored in access to the Lake, the Golf Course, the Pool, Summer Concerts and Security.

The best part was even better — No city income tax. It recently increased to 1.85% in Delaware. Ouch!

If I lived almost anywhere else, I'd be paying for services and taxes without the amenities of HAH.

Let me say it again — I'd be paying more and getting less.

Here what's going on with a few of our surrounding communities:

Baltimore: Fees + 1.00% income tax
Bremen: Fees + 1.00% income tax
Millersport: Fees + 1.00 % income tax
Sugar Grove: Fees + .75% income tax

If you add up fees and income taxes from our neighboring communities, would you be paying less than \$2,400 a year?

We do have one thing in common with our neighbors. We all have doubts and disagreements over how our money was spent.

Here's what we don't have in common:

The communities can pass fees increases with impunity.

The communities can increase income taxes with a simple majority.

The communities don't have the amenities enjoyed by residents of Hide-A-Way Hills in spite of their fees and taxes.

The communities don't have the same investment of sweat equity created by the many volunteers in Hide-A-Way Hills.

When I reflect on all of this, the assessment increase is an easy decision.

I'm voting "yes" for my neighbors.

I'm voting "yes" for my home.

I'm voting "yes" because this place is special.

I do this knowing there will likely be some mistakes made. There will be some plans delayed or changed. The things I want first may not happen. The things I don't want may happen anyway.

I can live with it.

I trust that my Hide-a-Way Hills neighbors love this place as much as I do.

Let's be united in meeting the needs of our community, our neighbors and the employees of Hide-A-Way Hills.

Please join me in voting "yes."

As members since 1972, we finally chose HAH as our retirement location because of all the amenities provided. Regarding the assessment increase we, being on a fixed income, had to justify this to ourselves.

The \$30.00 per month (\$360.00 per year) initial increase is less than \$1.00 per day. Adding the \$10 additional per month (\$120 per year) is less than \$.033 per day. This totals to less than \$1.32 per day. We compared that with the things we all purchase every day like coffee, sodas, beer, cigarettes, cookies, chips etc. So \$1.32 is good deal for all we receive.

Our Condo in North Canton had a monthly fee of \$165.00 which included lawn care, snow plowing and trash pickup....no Lakes for boating, fishing, swimming, no Pool, no Golfing, no Clubhouse, no Lodge, no Tennis, no Shooting Range, no Airport, no ORV Track, no Amphitheater, nothing....

DECIDE TO RISE



HAH Members:

I expect many of you are as outraged as I am about Ballot Issue #3 which proposes a 24% increase in our monthly assessment. This is particularly troubling in light of the pandemic we are currently facing. While the government, banks and landlords are trying to ease the financial burden on families while people are experiencing loss of jobs and many businesses are struggling, HAH is again pressing for an unreasonable increase in monthly dues. Management needs to be accountable and transparent. Many of our members are on fixed incomes that are tied to the increase in the cost of living index. Management should be able to keep the increase in our expenses within that cost of living index.

Even though the membership has voiced their opinion by voting against such increases, the Board continues to request large increases. Apparently, if such high increases are needed, our dollars are not being well managed. Management needs to review our expenses and determine where cuts can be made or increases limited. Business decisions need to be made in a responsible manner. None of us would accept a 24% increase in property taxes, utilities, cost of groceries, insurance or any other household expense. It is time to look at what is driving the increase in expenses and address those items. Any business should look at expenses where the expense is out of line for the benefit it provides and evaluate what adjustments are necessary. Perhaps we need to change or implement a bidding process for road maintenance, mowing and landscaping, insurance, building maintenance, trash removal and other services required to maintain our grounds and buildings. Some of our members may have resources that could reduce our expenses.

A ten-year automatic annual cost of living increase in the assessment was passed several years ago. To illustrate the cost of compounding over the first five years, assuming a 3% annual increase, that assessment compounds and increases from \$1030/\$1000 to \$1159.28/\$1000:

Year 1 $\$1,000.00 \times 1.03\% = \1030.00

Year 2 $\$1030.00 \times 1.03\% = \1060.90

Year 3 $\$1060.90 \times 1.03\% = \1092.73

Year 4 $\$1092.73 \times 1.03\% = \1125.51

Year 5 $\$1125.51 \times 1.03\% = \1159.28

By the tenth year, that \$1,000.00 has grown to \$1343.92, more than a 34% increase.

The members approved that automatic increase, at least in part, on assurances that once the assessments were tied to the cost of living, we would not have to face any other increases for ten years.

Comments from other members have been published in the newsletter regarding the \$78.00 increase in the monthly assessment since 2002 and the annual road assessment fee of \$200 annually that was intended to cover the cost of road maintenance. The membership also paid to have the dam rebuilt, and many are still paying it. The initial membership fees have increased substantially over the years. The Lodge is a great idea but is cost prohibitive; this has been evident for years. Someone's suggestion to lease The Lodge to a private party below market is worth pursuing to have a small profit instead of a large loss.

MEMBERS MUST VOTE IN THE AUGUST ELECTION TO STOP THIS ASSESSMENT INCREASE.



Vote "NO" Monthly Large Assessment Increase

Life is unpredictable, as in the stock market plunge and the health emergency of the new coronavirus. But, it was nice here in HAH's to know your monthly assessment rose at the CPI based rate each year. It has been a feeling of peace, comfort and reliability to know that a person can afford to retire while staying within their means.

Disregarding the unsuccessful passage last August, of the large \$60 monthly assessment increase is disrespectful to the long standing HAH members who voted against the huge increase. The fact is that approximately 15 times the normal yearly assessment increase, (\$30 then \$10 added next year), is too much to ask most HAH members.

Perhaps a one time \$10 per month assessment increase could be passed to shore up the most important situations, along with our regular CPI based increase each year. That is approximately 4 times the regular yearly increase.

Management must reign in the cost of running the Hills and stop relying on the older members (fixed income, retired) to pay money we don't have. Budgeting is painful but necessary.

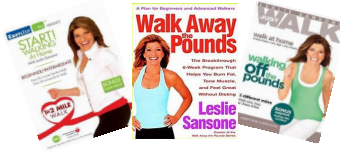

~ATTENTION MEMBERS~

The beach docks are not to be used for overnight or long-term storage of your boat.

If you do not have a public dock or a place at a member home on the lake to store your boat when not in use, it needs to be taken off the lake for the night.

It can be stored overnight on a trailer at the base of the dam by the shelter house for next day use.

MEMBER/GUEST OUTING – Players must be 21 years old.

CALCUTTA – Is open to members, family guests and social guests with established HAH handicaps. All payers must have a HAH handicap. A HAH member will always have priority to play over a family or social guest. USGA rules apply unless superseded by local HAH rules. Players must be 18 years old. NO GALLERY ALLOWED UNTIL PLAY OFF. AT THE DISCRETION OF THE GOLF COMMITTEE ADDITIONAL TOURNAMENT RULES MAY APPLY FOR SANCTIONED EVENTS.

HANDICAP FEE is \$10.00 per skill level (i.e., silver/gold/white) and should be paid by June 1. Please include your Name, Lot Number and skill level (i.e., silver/gold/white) on the envelope when paying your fee. There is a wooden box in the clubhouse for your fee and scorecards.

HIDE-A-WAY HILLS CLUB ORV RULES AS OF 3/25/17

VEHICLES

14. Notwithstanding the above numbered Vehicle Rules, and the Off Road Vehicle Rules that apply to the designated ORV track and trails, the following shall apply to all Off-Road-Vehicle (ORV) operators under the age of 16 when using Hide-A-Way Hills roadways. "ORV" shall include, but not necessarily be limited to any ATV, Utility Vehicle, Side-By-Side, Go-Kart, Dirt Bike or Golf Cart. It shall not include cars, vans, trucks and SUV's.
 - A. All ORV operators under the age of 16 and their parent(s) must attend a HAH ORV Rules Meeting sponsored by the ORV Committee.
 - B. No ORV may be operated by a person under the age of 12 without a parent or responsible adult present.
 - C. Such ORV operators must understand and comply with the vehicle manufacturer's recommendations for safe operation and ensure that the maximum number of passengers does not exceed the number of seats in the vehicle.
 - D. In addition, helmets must be worn by all such operators and riders of an ATV, Go-Kart or Dirt Bike. Seat Belts must be worn by all such operators and riders in vehicles where they are supplied. Go-Karts and other low-profile ORVs less than 4 feet from the ground must display a flag extending vertically at least 4 feet.
 - E. The parents of all under-age ORV operators must read and sign the "Parental Consent and Release" form acknowledging the inherent risk associated with operating an ORV, and attesting that they and their child understand and will comply with all HAH rules.
 - F. Upon confirmed attendance at an aforementioned ORV Committee sponsored meeting, and completion of the "Parental Consent and Release" form, a sticker will be issued for display on any ORV to be used by an under-age operator. No ORV shall be operated by an under-age driver on HAH roadways without such a sticker clearly displayed. Violations of these rules are subject to the Schedule of Fines section of the Hide-A-Way Hills Club Rules.

OFF-ROAD VEHICLE (ORV) RULES

The following rules cover use of the Hide-A-Way Hills ORV track and trail area. All existing Hide-A-Way Hills Club rules also apply.

1. The use of the ORV track and trail area is restricted to Hide-A-Way Hills members and guests on member owned ORVs. Social guests must be accompanied by the member.
2. Please enter the ORV track from the posted entrance point.
3. The ORV track is one-way only—counterclockwise. Do NOT go clockwise or cut the track.
4. When riding the trails through the woods, do not cross the signs marking the shooting range.
5. The ORV Committee strongly recommends that a certified helmet be worn by all riders.
6. The ORV Committee strongly recommends that participants riding in side-by-side UTV's fasten their seat belts.
7. Due to the possibility of an accident requiring a call for medical assistance or other help, the ORV Committee strongly recommends that riders not be alone on the track or trails.
8. Riders are prohibited from using the ORV track or trail area while impaired by the use of alcohol or drugs.
9. Ride at your own risk, and take care to not exceed your ability to control your vehicle.

The ORV Committee strongly recommends that riders 12 and under be accompanied by a parent or adult.
The parent or adult should be at the track but does not have to ride.

With firearms sales skyrocketing, a lot of people are buying guns without any safety or use training. Our Range Safety Officers are NRA certified instructors. We can teach or refresh proper safe handling, shooting skills and even show you how to clean your firearms.

We will continue, as always, to leave it up to the discretion of the assigned Range Officers to close because of weather, illness, or Covid related issues. We have our schedule laid out for the year, things happen, we try to cover each other, most times successfully, sometimes not. We are volunteers so please have a heart if the RSO must cancel his day or weekend.

We would like to recognize and thank JD Flaherty for his years of service to the range and Hide-A-Way Hills. While he still is a member, he has resigned his status as a Range Safety Officer and we have moved him to an emeritus status.

Hours of operation are from 9am to sunset on Saturdays and 12pm to sunset on Sundays. We do ask that you give the Range Officer on duty a 48-hour notice of your intentions to shoot. Small registered groups will meet at the Range, not the guard shack.

As of right now, we are planning on having our trap shoot on 13 September, and "Come Shoot With a Veteran Day" on 8 November both starting at 1:00 pm.

A) I have heard about previous and rumored mismanagement of funds. I have not personally seen this. The 2020 operating budget had to be trimmed due to projected revenue shortages. HAH cannot take on debt so we need to live within our means. Currently there is no large reserve. If a lake fails or a plow truck goes down, there are no reserves to cover it. If the amenity or equipment is essential the money needed will be taken from other funds which will have a budget shortfall. HAH needs to maintain some type of rainy-day fund. Our community is large and member's expectations are high.

A) Financial responsibility rests with our Management Committee which is overseen by the Board. I was MC Chair (7yr) and Board member (3yr). Issues are analyzed ensuring resources are used optimally, but with attention to long-range needs. I.e, some roads were "Moto-Paved" at great expense; members liked them plus we don't need to treat them annually. Maintenance staff and the small annual savings can be directed to other areas where roads are deteriorating. We were fiscally responsible, and made difficult, necessary decisions. Based on analysis, the BOT/MC have called for additional revenue. Without an assessment increase, costs were cut including recycling, seasonal workers, and, Lodge operations' subsidy. The Club budget was balanced but will become unbalanced as costs continue to increase. What more shall we cut? Do we want less or no security? Do we want declining one-lane roads? No Lodge of any sort? Not me! Please vote YES!

B) Security is one of our most highly valued amenities. Our Security Staff does a great job helping members, providing Lake Patrol, policing the roads, and enforcing Club Rules. MANAGEMENT COMMITTEE REPORT – Jim Sigafoose

- Management Committee Opening – We have had six members submit applications for the management committee opening. We hope to interview those at our first meeting in August and make a recommendation to the board at the August annual meeting.
- General Manager Search Committee – I currently have four members that have volunteered to be on the committee. Would like to have one current board member volunteer. Jim Krygier volunteered to be the board representative.
- Lake Deerfoot – Management committee member Steve Cundiff is working on a plan of attack for the algae and weed issues in that lake including running the aerator and applying copper sulfate.
- Clubhouse Staffing – We are continuing to look for one additional part time person. Business has been good as we made a slight profit in June. We added Sunday's hours but the last Sunday was dismal.
- Package Delivery – Member Eric Boysko is working with the management committee on a comprehensive study of the package issue in the club. Eric plans on coming back with a multi-facetted approach to relieve the situation. There is no one solution. We need to urge members to pick up their packages as soon as possible.
- The food service committee has met and went over the preliminary plan for a lodge reopening as well as addressing issues at the clubhouse. We are meeting again on August 4th to come up with some concept for a remodeled lodge that will better serve the membership.
- HAH Road Plan – Committee Member Rex Eberly worked extensively on a road plan with Rick O'Neil. We are hiring a contractor to do chip and seal primarily on the west side of the LOFS. Our maintenance crew will be focusing on asphalt repairs, sweeping and ditch repairs.
- Brewery - Committee Member JJ Jeffers is meeting with the brewer to discuss his plans to brew beer. We have asked him to get our beers brewed and hopefully he will have a batch done soon.
- HAH Financial Audit – The club is scheduled to have a 2 year financial audit done this year (for 2019 and 2020). The cost will be around \$12k to have this done. The board is to decide if they want this completed.

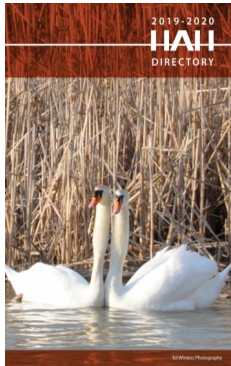
